This position is a remote work opportunity based out of the comfort of the successful applicant's home office and will require some travel.

## Key responsibilities will include:

- Review technical documentation to summarize and identify possible indigenous community concerns;
- Write independent review reports and provide recommendations;
- Assist with consultation activities including:
  - o preparation of presentations;
  - o preparation of meeting documents; and
  - documentation of discussion items;
- Assist with development of processes and protocols for clients;
- Assist in the development and facilitation of internal cultural awareness training for staff members;

  Procedures, Standards and Guidelines in the execution of all work; and
- Other duties, as assigned.

- Experience in Indigenous Communities and way of life (as a member, frequent visitor, through education or other)
